(Revenue \$) In 2010, the Norwalk Community College Foundation provided financial assistance to 462 students through a number of scholarship initiatives, such as academic year scholarships, spring semester scholarships, program specific scholarships, student success funds, textbook scholarships and transfer scholarships to 4-year educational institutions.

4b (Code:) (Expenses \$ 666,182. including grants of \$ 611,588.) (Revenue \$) In 2010 the Foundation continued funding College programs aimed at innovative curricula development, professional development for management, staff and faculty, various College events, programs and initiatives. The Foundation also supported the College's efforts to expand the capacity of its nursing program by funding nursing faculty and staff positions, equipment purchases, programmatic support and faculty/staff professional development.

4c (Code:) (Expenses \$ 358,330. including grants of \$ 328,933.) (Revenue \$) In 2010, the Foundation provided funding for fixtures, furniture and equipment for the new Center for Science, Health and Wellness, a 55,000 sf LEED certified state of the art building due to be completed in 2011. The building will be the new home of the College's nursing and allied health programs, science laboratories, classrooms and offices.
