Typically on any given month there will be 3500 participants who attend meetings at The Center for Spiritual Development. In addition to hosting meetings, As a trusted resource to partners in the recovery community, the Ministry assists families and individuals referred to them. Clinical providers know the Ministry will help families and individuals select an appropriate meeting, sober living options and other treatment providers. Ministry staff meet with families and individuals and offer them a safe, confidential, and non-clinical environment to discuss challenges and concerns. Staff describe how 12 Step meetings are run, the benefits of sober living and recovery and offer hope for the future.
