### SAAVI Services for the Blind Statement of Program Accomplishments

- Comprehensive Day program services for blind adults through DES-Rehabilitation Services Administration. Services include Orientation and Mobility training for independent travel; Home Management training; Braille; Access Technology; Advocacy and positive Philosophy of Blindness groups and individual counseling; Career Exploration, Job Readiness and Job Placement/Retention; GED preparation; English as a Second Language; and Health and Wellness. In fiscal year 18-19, these comprehensive services were providing for 43 in Phoenix, 27 in Tucson, and 21 in Yuma.
- Academic Supported Education for 20 blind college students in Tucson, 6 in Yuma, and 34 in Phoenix.
- Adult Residential Services for 6 blind vocational rehabilitation students.
- Residential Program for 16 blind and visually impaired individuals transitioning out of high school (Steppin' Out Program).
- Six-week Summer Residential Camp (Ready Set Go Youth!) for 20 blind high school Transitional Youth, ages fourteen to twenty years old.
- Reaching Empowerment through Achievement and Learning (R.E.A.L.) Program for Blind Children. Services included:
  - Two-week Summer Day Camp (NFB Bell Academy) for 34 blind children, ages five to twelve.
  - Weekend programming events for blind youth, K-12<sup>th</sup> grade: 56 students and 163 parents with twenty activities and events, including daily living instruction, communication skills, orientation and mobility training and a variety of social and enrichment activities.
- Using vehicles previously provided as part of the Federal Transit Program to be used throughout the state to provide transportation to students and blind staff, SAAVI provided 10,200+ rides for blind individuals; 270,000 miles were driven.
- Provided Independent Living services statewide for an average of 37 individuals per month who are blind, 85% of whom were seniors over the age of 65.
- Provided Day Treatment Activities for 19 developmentally disabled individuals who were also blind or visually impaired. 1,736 hours of programming were provided with 28,176 units of service. Contract for these services are with the Arizona Department of Developmental Disabilities.
- Phoenix Children's Sports Activities conducted 14 events for blind children of all ages. The program served 150 students and 300 family members, with 138 hours of direct activities including introduction to Goal Ball

(Olympic event), indoor rock climbing, Beep baseball, karate and martial arts classes, and a hiking/biking event.
