In FY13, FPS assisted 150 families and provided respite vacations to 99 families (a 3% increase over prior year). FPS offers young adult cancer patients ages 24 to 50, and their families a retreat from the unyielding physical and emotional demands of cancer by providing expense paid respite vacations to address the psychological, emotional, economic and spiritual trauma associated with a cancer diagnosis. To be eligible for the program, a patient must be nominated by a member of his/her oncology team. FPS nominators use clinical assessment factors to best identify patients in need of respite. New nominators participate in a short educational program about the mission of FPS. Some nominators serve as members of the FPS program advisory committee, charged with overseeing the entire patient program, program guidelines and clinical assessment factors.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)

Evaluation of the program is assessed in part from statistics derived from the patients' evaluations and impact study; and also an independent evaluation by the patient nominator. Since measurement began, the overall rating of the improved ability to cope with cancer is 3.84 on a scale of one to four. In an effort to remain transparent, FPS posts its patient and nominator outcome measures on its website. One hundred percent of all nominating professionals recognize post-respite improvement in the patients and patient's family/caregiver's ability to cope with cancer. In FY13, FPS also began a research study to better measure the effects of the respite vacation on the patient, caregiver and children. A questionnaire has been created with the help of experienced psychologists and oncology nurses, with a trial study expected to begin in the winter of 2014.

During FY 2013, FPS received its largest single cash gift. The gift was restricted for the purchase of a second home in memory of Johnny Murabito, Jr., maintenance of said property and program costs associated with Johnny's House. In addition to Johnny's House, FPS owns another property in the Orlando area which is used year round for respite vacations. FPS uses donated vacation homes and resorts for respite vacations. In FY13, FPS received almost \$500,000 of in-kind support for the program in the form of complimentary office space, patient accommodations, professional and marketing services, respite supplies and special event goods and services. Noncash contributions are critical to the Organization's success and allows FPS to best use its constituent dollars.

At the end of FY13, FPS began a staycation program aimed at providing an "in-home" respite experience for patients too sick to travel. In addition to a cash stipend, FPS provides gift cards, inspirational writings, blankets and other amenities to these patients and their families.

FPS is a proud recipient of the Pennsylvania Association of Nonprofit Organizations (PANO) Standards for Excellence certification. This award recognizes FPS as an ethical and accountable organization dedicated to the highest level of excellence within the nonprofit sector. This award is bestowed only to the most well-managed and responsibly governed nonprofit organizations that have demonstrated compliance with the 56 specific Standards for Excellence based on honesty. FPS is one of 50 nonprofits statewide and the first nonprofit in Montgomery County to hold this honor from over 11,000 registered PA charities. FPS has met, complied with, and integrated the certification program and thus, all governance questions asked in the Form 990 have been addressed by the Organization in its normal course of business. In 2009, the FPS Standards for Excellence award was recertified by PANO and this certification remains for five years.

For Pete's Sake hosts 4 major special events a year, including a walk at Citizens Bank Park in Philadelphia. These events provide almost 20% of the Organizations income. Additionally, FPS supporters host community fundraising events, including 5k runs, Flip Flop Fridays and corporate and school dress down days. These community events raised 20% more in FY13 than over prior year. FPS is funded 100% by donations from private individuals, private foundations, corporations and community support.
