IN 2012-2013, THE RTP STAFF ENGAGED 1,500 VOLUNTEERS IN SERVING 84 HOMEOWNERS AND THREE ORGANIZATIONS AND TRANSFORMED FOUR LOTS/COMMUNITY GARDENS. TO DO THIS, VOLUNTEERS WORKED ALONGSIDE FAMILIES TO MAKE ESSENTIAL HOME REPAIRS RANGING FROM CARPENTRY, PLUMBING, AND ELECTRICAL TO PAINTING AND REORGANIZING. THIS ALSO RESTORES VALUE TO HOME. ENERGY-EFFICIENT UPGRADES INCLUDE ENSURING THAT EVERY HOMEOWNER HAS A FUNCTIONING HEATER AND A SOUND ROOF. HOME MODIFICATIONS FOR OLDER ADULTS AND PEOPLE WITH DISABILITIES ARE ROUTINE COMPONENT OF WORK SCOPES.
