The elected trustees may serve up to two consecutive terms. Trustees elect the officers. The trustees represent the members at-large for all activities of the organization. The trustees meet regularly as a group and each trustee serves on at least one committee. Minutes are preserved by the board and any committee are recorded. Minutes are approved by the board and are preserved in accordance with the records retention policy. Committee meeting minutes and results of election, voting, etc. are also preserved in accordance with the records retention policy.

Form 990, Part VI, Section A, Line 7b - Beaver Creek Wetlands Association consists of members who are offered the opportunity to appoint trustees by a simple majority vote annually. The elected trustees may serve up to two consecutive terms. Trustees elect the officers. The trustees represent the members at-large for all activities of the organization. The trustees meet regularly as a group and each trustee serves on at least one committee. Minutes are preserved by the board and any committee are recorded. Minutes are approved by the board and are preserved in accordance with the records retention policy. Committee meeting minutes and results of election, voting, etc. are also preserved in accordance with the records retention policy.

Form 990, Part VI, Section B, Line 11b - The form 990 is completed by the treasurer and the executive director and then sent to our accountant for review. The board of trustees receives a copy for review before it is filed. A copy is made available on our website and by request.

Form 990, Part VI, Section B, Line 12c - BCWA requires that each officer, trustee and employee annually sign a comprehensive conflict of interest policy and gift policy and disclosure form. The trustees, employees and members share responsibility for monitoring compliance with these policies, with any concerns heard and addresses by the president, vice president or any member of the executive committee. This process works in conjunction with our whistleblower policy.

Form 990, Part VI, Section B, Line 15 - The hiring committee, as formed by the board of trustees, utilized data from comparable organizations and nonprofits when determining the salary and compensation for the executive director. The board of trustees approves the compensation for the executive director during a regular board meeting. No trustees receive compensation.
