Thank you for choosing Dustin Wood, CPA to assist with the 2017 taxes for ALTERNATIVE ENERGY RESOURCES ORG. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

We will prepare the 2017 federal and state income tax returns for ALTERNATIVE ENERGY RESOURCES ORG. We will depend on management to provide the information we need to prepare complete and accurate returns. We may ask management to clarify some items but will not audit or otherwise verify the data submitted.
