SLY WAS DEVELOPED IN 1998 AFTER TEEN FEED BECAME CONCERNED THAT MANY HOMELESS AND STREET-INVOLVED YOUTH WERE NOT COMFORTABLE ACCESSING TRADITIONAL AGENCY-BASED SERVICES. UNLIKE TRADITIONAL "CASE MENAGEMENT," SLY WAS DESIGNED AS A YOUTH-CENTERED SUPPORT PROGRAM THAT AFFIRMS THE STRENGTHS OF EACH PARTICIPANT AS THEY MEET SELF-IDENTIFIED GOALS. OUR SUPPORT COORDINATOR BUILDS A RELATIONSHIP WITH EACH YOUTH TO LEARN WHAT TYPES OF RESOURCES WILL HELP THEM BEST SUCCEED. SLY IS UNIQUE IN ITS FOCUS ON MEETING YOUTH ON THE STREETS AND IN PROGRAMS, AND IT SERVES A BROADER RANGE OF YOUTH - AGES 13 TO 25 - THAN MOST OTHER PROGRAMS. DURING THE YEAR ENDED
