



**Mission Statement**

Acting as the cooperative body of the member congregations, WCM develops, facilitates and delivers programs to meet the physical, social, economic and spiritual needs of Wilkinsburg families, individuals and member congregations.

**Program Details**

Emergency Food Pantry: Food is distributed to those who are in a crisis situation in need of emergency food. A referral from a social worker or a church affiliate is required to receive food from the pantry. Meals on Wheels: Meals on Wheels of Wilkinsburg's mission is to enhance the quality of life through nutritious meals and personal contact with the goal of improved social, physical and nutritional betterment of vulnerable Americans. We provide 65 meals per day, five days per week, to those who qualify for and are in need of the home delivered meal services. After School Food Program: We provide lunch and dinner to 3 school program sites, feeding 90 children per day, Monday- Friday. We make sure each meal is well balanced and nutritious meeting all nutrition requirements.

**Accomplishments**

Fiscal Year Ending 2007

1. We have grown the number of families and individuals served through our Emergency Food Pantry, as well as through our Angel Food Program. We serve on average 100 individuals per month, through those combined programs.
2. WCM has developed and established new staff and management, creating a constant stability for programs and services. All of our programs have grown since these changes took place in 5/2007.

**Objectives**

Fiscal Year Beginning 2008

1. To change the face of our pantry to be a hunger prevention program, rather than an emergency food program, whereby individuals and families can use our program on a continual basis, rather than 1x per year.
2. To expand and recruit more volunteers for our Meals on Wheels program.
3. To hold one fundraiser and increase the number of foundational gifts to WCM.
