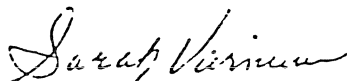

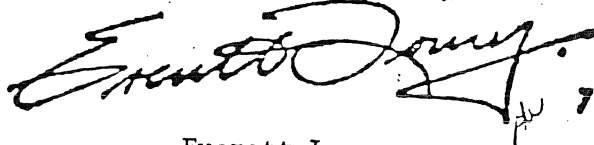
Your exempt status under section 501(c)(3) of the code is still in effect.

Because this letter could help resolve any questions about your foundation status, you should keep it in your permanent records.

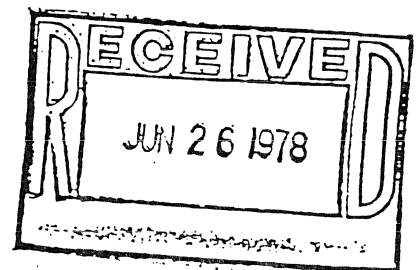

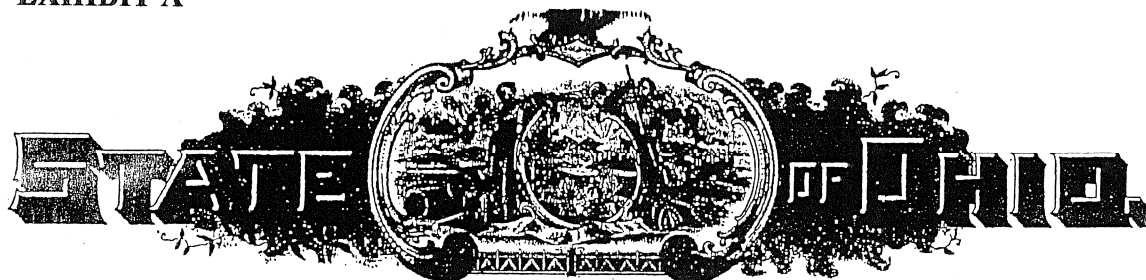

THESE ARTICLES OF INCORPORATION OF

TOLEDO SOCIETY FOR CRIPPLED CHILDREN.

WITNESSETH, That we, the undersigned, all of whom are citizens of the State of Ohio, desiring to form a corporation, not for profit, under the general corporation laws of said State, do hereby certify:

FIRST. The name of said corporation shall be The Toledo Society for Crippled Children.

SECOND. Said corporation is to be located at Toledo, Lucas County, Ohio, and its principal business there transacted.

THIRD. Said corporation is formed for the purpose of the charitable care and treatment of crippled or otherwise physically defective children and of adults requiring orthopaedic treatment; to establish, conduct and maintain a home or hospital for said purposes; and to acquire, through donations and otherwise, and to own, all property and funds necessary or convenient therefor.
