During 2020 the Hermitage rescued 709 cats and kittens and had 626 adoptions! The Hermitage provided and continues to provide medical treatments for all the resident cats to include, diabetics, FIV, FeLV, and geriatrics, and all special need cats. The shelter helped the community through the spaying/neutering of 347 cats in 2020. This reduced the amount of unwanted, homeless cats in Pima County. The Hermitage also participated in the Food for People's Pets program. We distributed 74,387 pounds of pet food and litter in 2020, which was provided to families experiencing financial hardships.
