THE GOAL OF THE SUPPORT PROGRAM GROUPS IS TO PROVIDE LGBTQ+ SENIORS AN OPPORTUNITY TO BUILD COMMUNITY WITH PEERS FACING SIMILAR CHALLENGES, IN A SAFER, AGE- AND LGBTQ+-AFFIRMING SPACE. THESE GROUPS CAN PROVIDE AN INCREASED SENSE OF SELF-WORTH AND SELF-KNOWLEDGE THROUGH SHARED VULNERABILITY, CHALLENGE, AND TRUST, AND CAN EMPOWER GROUP MEMBERS IN HOW THEY APPROACH RELATIONSHIPS OUTSIDE OF THE GROUP. GROUP FACILITATORS ARE OFTEN OPENHOUSE CLIENTS THEMSELVES AND HAVE LONGSTANDING HISTORIES OF PARTICIPATION IN ACTIVIST GROUPS, THERAPY GROUPS, AND CONSCIOUSNESS RAISING GROUPS THAT BOLSTER THEIR FACILITATION.
