In connection with this grant, the Theater entered into a fiscal sponsorship agreement with Costume Connection Houston (the Connection) to operate the costume connect program. The Connection is a shared warehouse and wardrobe maintenance facility supporting the performing arts ecosystem of the Houston region.

Main Street Theater (MST) opened in 1975 and for the past 46 years, it has served the Greater Houston community with engaging and enriching artistic programming while also providing meaningful professional opportunities for Houston's theater artists. MST strives to create theater that is representative of its community on both its MainStage and Theater for Youth. MST's adult audiences experience challenging and thought-provoking works, while its Theater for Youth programming is designed to supplement classroom curricula and inspire students to explore their imaginations.

From September 2019 to February 2020, MST presented 385 performances of 8 productions to a total audience of 74,719. As a result of the COVID1-19 pandemic, MST moved to create free and low-cost digital programming that could be enjoyed by Houstonians of all ages while the theater was closed for in-person productions.
