Financial assistance is targeted to help with a family's rent, utilities, prescriptions or other medical needs. Services were provided to 33,452 (duplicated) people in crisis during 2021.

4b (Code:) (Expenses \$ 312,353. including grants of \$ 4,558.) (Revenue \$) JobNet assists the unemployed in conducting an effective job search. In 2021, 270 people were helped.

4c (Code:) (Expenses \$ 296,883. including grants of \$ 238,726.) (Revenue \$) Back to School provides disadvantaged students with grade-appropriate school supplies and new clothing at the start of each school year. A total of 6,802 students received assistance in 2021.
