Youth Programs- Create park stewards for tomorrow: To meet the growing disconnect between kids and nature, especially children from diverse communities, both urban and rural, NPT launched two national environmental education initiatives: the Buddy Bison School Program (in 2009) and Kids to Parks Day (in 2011) to provide park and public lands/water experiences for youth, families, and teachers. Park experiences funded by NPT: 1) provide outdoor education using parks and public lands/water as outdoor classrooms; 2) promote health and wellness through outdoor recreation; and 3) promote the importance of park stewardship and conservation.

(Revenue \$) Land and Parks Programs- Preserve parks today: For 34 years, National Park Trust (NPT) has enhanced the nation's park system by acquiring high-priority land identified by the National Park Service (NPS) and other agencies. To date, NPT's efforts have resulted in the completion of over 60 land acquisition, restoration and mitigation projects for more than 45,000 acres in 29 states, Washington, DC and one U.S. Territory. These have included 47 NPS projects in 41 NPS Units, 3 U.S. Department of Agriculture Forest Service projects, 3 National Wildlife Refuge projects and 9 state and local parks.

Preserve parks today: For 34 years, National Park Trust (NPT) has enhanced the nation's park system by acquiring high-priority land identified by the National Park Service (NPS) and other agencies. To date, NPT's efforts have resulted in the completion of over 60 land acquisition, restoration and mitigation projects for more than 45,000 acres in 29 states, Washington, DC and one U.S. Territory. They rotated between canoeing on the Anacostia River and engaging in hands-on activities on land to learn about local animals, plants, water quality, and the water cycle.

Washington, D.C.:

Program is yearly in October 2012 to present: 1000 students from local D.C. Buddy Bison Schools canoe on the Anacostia River with National Park Service, the Army Corps of Engineers and Wilderness Inquiry.

(Participating schools include: Stokes PCS, Neval Thomas Elementary, EL Haynes, West Education Campus, Patterson Elementary, and Friendship Public Charter School)

March 2013 to present - Students from St. Ignatius Loyola Academy in Baltimore, MD traveled to the National Mall and Monuments. They learned about US history by discussing the important people that helped shape our nation at the monuments and memorials devoted to their memory.

April 2013 to present - NPT brought 30 fifth grade students from Washington Jesuit Academy to Rock Creek Park where they learned about their local wildlife and studied planets at the only planetarium in a national park.

Oct 2014 to Present - 40 third-grade students from Neval Thomas Elementary visited the National Mall and Memorials park to see the places they studied in school.

May 2017: 50 3rd graders from Children's Guild Charter School visited the National Mall. Students toured the monuments and learned about interesting facts while searching for hidden gems at each monument.

Kids to Parks Day

This national day of play was launched in 2011 by National Park Trust.

May 20, 2017: 456 mayors and 22 governors participated and promoted the event. A Senate resolution was passed and there were 1,735 park events registered at KidstoParks.org. More than 1 million participated coast to coast and 70 school contest winners were selected representing 29 states + D.C. As a result of the school contest, NPT provided park experiences for over 3,700 students. Each park experience was based on the three pillars of NPT's youth programs: outdoor recreation, education, and park stewardship.

NPT moves quickly to select, acquire and protect parkland, often working with partners, including national and local land trust and friends groups, to raise the critical funding needed to complete projects. NPT's land projects vary in size from great swaths of land, including the more than 10,000 acres to create the Tallgrass Prairie National Preserve (KS) to equally important smaller parcels, such as the 12.5 acres located within the Wild Basin area of Rocky Mountain National Park (CO).

NPT continues to make great progress with our park conservation efforts. In the late 1990s, we were the lead organization to create a new unit of the national park system dedicated to preserve our country's prairie ecosystem - the Tallgrass Prairie National Preserve. NPT continues to be instrumental in adding critical private lands to other parks including Kennesaw Mountain National Battlefield Park, GA; Bruce Vento Nature Sanctuary, MN; Yosemite National Park, CA; and Harpers Ferry National Historical Park, WV. In 2014, we transferred the title of the Ivanpah Desert Tortoise Research Facility in Mojave National Preserve, CA to the National Park Service to help protect this endangered species. We continue to support the facilities research. In 2016, we transferred the title to 32 acres of needed land for Indiana Dunes National Lakeshore, IN to the National Park Service.

NPT holds the conservation easement on this 2000 acre ranch, which abuts the Ouachita National Forest and the Poteau Mountain Wilderness Area. The forest is home to 79 proposed, endangered, threatened, and sensitive species. The easement also provides habitat protection for the bald eagle. The conservation easement benefits both the Wilderness Area and the National Forest by providing a buffer zone to ensure the continued ecological viability of these federal assets. NPT is working with Wilderness Land Trust and the Rocky Mountain Conservancy to protect 32 acres of wilderness within the national park. The house on this property located within the national park will be removed to restore the pristine landscape in the Wild Basin area.

The federally-listed threatened Canada Lynx roams nearby along with moose, fisher and black bears. It is one of the largest 150-year-old forest blocks in central Maine.

Pictured Rocks National Lakeshore (2017-present)

NPT has begun the purchase of an important historic property to benefit Pictured Rocks National Lakeshore (MI). The Munising Range Lights and Keeper's House complex, in service since 1908, is owned by the NPS and still operated by the U.S. Coast Guard as an aid to navigation. Behind the Keeper's House is a small piece of private property with a non-historic house. Purchasing the property and removing the non-historic house is a priority for the park because it would likely improve the historic site.

NPT has helped raise funds for the ecological restoration of this unique 27-acre park on the Mississippi floodplain east of St. Paul, Minnesota. Funding for interpretation and park amenities was also provided.
