THE PHELAN MC-DERMID SYNDROME INTERNATIONAL REGISTRY (PMSIR) :TO MOVE FROM BASIC LABORATORY RESEARCH TO MEANINGFUL THERAPIES AND TREATMENTS RELATED TO PHELAN-MCDERMID SYNDROME (PMS), THE PMSF FUNDS THE PMSIR. THE PMSIR IS IMPORTANT FOR CHARACTERIZING AND UNDERSTANDING PMS BETTER AND PROVIDES VALUABLE INFORMATION FOR FAMILIES AND DOCTORS TO MAKE THE BEST CARE DECISIONS POSSIBLE. IT IS ALSO A TOOL TO HELP RESEARCHERS FIND PATIENTS WHO MIGHT BE A GOOD MATCH FOR THEIR STUDIES.
