Thank you for choosing Shelly M Henderson, EA to assist with the 2022 taxes for Drawchange Inc.. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

We will perform accounting services only as needed to prepare the tax returns. Our work will not include procedures to find defalcations or other irregularities.
