Drawchange Inc:

Thank you for choosing Henderson Business Services to assist with the 2023 taxes for Drawchange Inc. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

We will prepare the 2023 federal and state income tax returns for Drawchange Inc. We will depend on management to provide the information we need to prepare complete and accurate returns. We may ask management to clarify some items but will not audit or otherwise verify the data submitted.

We will perform accounting services only as needed to prepare the tax returns. Our work will not include procedures to find defalcations or other irregularities. We will inform management of any material errors, fraud, or other illegal acts we discover.
