There are almost 200 Teen Challenge campuses in the United States, and over 1,000 centers world wide in over 80 countries, which provide Christian recovery services to individuals of every age and social background. Typically, these services are long-term residential recovery centers which provide a life-encompassing environment through which the participant is able to change their lifestyle and develop a plan for a future free from addiction. Another core tenet of Teen Challenge is drug abuse prevention, which educates young adults on the dangers and reality of drug abuse in our society. Teen Challenge admitted 344 men and women in
