We provide a broad range of integrated services for more than 10,000 older adult residents of the community each year, the majority of whom live on low-level fixed incomes.

Homeless and Housing Services: for the past two decades, the Neighborhood House has provided a comprehensive network of programs and services to homeless and formerly homeless men and women each year to help them gain independence and stability. Our Homeless and Housing Services Department provides support to more than 500 men and women each year who are homeless, formerly homeless, or threatened with eviction and life on the streets.
