Legal Advocacy: Our attorneys and advocates provide free, comprehensive civil legal services to individuals and families, frail older adults, people with disabilities and those experiencing homelessness, immigrants, low-wage workers and low-income families, with a primary focus on the East Side of Manhattan using a multi-disciplinary holistic approach to legal representation. We also access hundreds of clients through outreach at a variety of sites including soup kitchens, houses of worship, senior centers, hospitals and community centers.

Healthy Foods and Wellness: The Neighborhood House works to improve the health and wellness of thousands of individuals in need through diverse programs: The Teaching Kitchen at Lenox Hill Neighborhood House, a training, technical assistance and consulting program designed to assist nonprofit organizations with institutional food programs convert to our farm-to-institution model; a Community Supported Agriculture program; Art Therapy; and more.
