40 people with disabilities took 320 lessons. 14 of these riders participated in the Top Hands Horse Show and Curly open horse Show earning 10 first, 7 second, 11 third, 9 fourth, 14 fifth, 10 sixth, 4 seventh, 1 eighth, and 10 participation awards.

A mother re-enrolled her son at age 16 because when he was 8 he learned to walk by riding with Dream Catcher Stables.

A rider with autism whose 2013-14 school behavior was challenging, has dramatically improved behavior.

A rider with Down Syndrome is now a cheerleader at her school.

Six adjudicated youth completed 40 hours of court ordered community service. They weeded around our fences, assisted volunteers with other maintenance issues as warranted. The result -- a return to a positive life path.

3,493 volunteer hours given by 117 volunteers enabled our program to operate. This included 8 Houston Fire Academy Cadets giving 62 hours while learning about people with disabilities and horses, the Best Buy volunteer team helping on property and at our fundraiser, and 11 members the University of Houston NSCS Club spending a day with us and promising to return in 2015. This included working with our horses and our riders in the following capacities -- grooming, tacking, leading the horses; walking beside riders with balance or confidence issues; and some faci
