MIDDLETON OUTREACH MINISTRY'S FOOD PANTRY ALLOWS INDIVIDUALS TO SELF-SELECT FOOD AND PERSONAL HYGIENE ITEMS FOR THEIR HOUSEHOLDS ON AN AS NEEDED BASIS. INDIVIDUALS ARE ALSO ABLE TO SELECT GENTLY USED CLOTHING AND LINENS. DURING 2010, APPROXIMATELY 24,000 INDIVIDUALS WERE SERVED BY THE FOOD PANTRY WHILE OVER 14,300 INDIVIDUALS USED THE CLOTHING CLOSET. OVER 1,150 DISTINCT HOUSEHOLDS BENEFITED FROM THESE PROGRAMS DURING THE YEAR.
