MIDDLETON OUTREACH MINISTRY'S FOOD PANTRY ALLOWS INDIVIDUALS TO SELF-SELECT FOOD AND PERSONAL HYGIENE ITEMS FOR THEIR HOUSEHOLD ON AN AS NEEDED BASIS. INDIVIDUALS ARE ALSO ABLE TO SELECT GENTLY USED CLOTHING AND LINENS. DURING 2011, APPROXIMATELY 36,800 INDIVIDUALS WERE SERVED BY THE FOOD PANTRY WHILE NEARLY 18,000 INDIVIDUALS USED THE CLOTHING CLOSET. OVER 1,320 DISTINCT HOUSEHOLDS BENEFITED FROM THESE PROGRAMS DURING THE YEAR.
