THE FOOD PANTRY IS STAFFED BY OVER 280 VOLUNTEERS WHO DISTRIBUTED MORE THAN 1.3 MILLION POUNDS OF FOOD ANNUALLY TO AN AVERAGE OF 1,614 HOUSEHOLDS VISITS PER MONTH OF WHOM ROUGHLY 41% ARE CHILDREN. THE AMOUNT OF FOOD THEY RECEIVE IS BASED ON FAMILY SIZE WITH NO LIMITATIONS ON NUMBER OF VISITS OR INCOME LEVELS. ROUGHLY 40% OF OUR FOOD IS DONATED BY THE COMMUNITY, SCHOOLS, AND BUSINESSES.
