MIDDLETON OUTREACH MINISTRY DISTRIBUTES FOOD AND CLOTHING, THE MOST FUNDAMENTAL HUMAN NEEDS, SIX DAYS A WEEK TO RESIDENTS. THE FOOD PANTRY AND CLOTHING CENTER IS STAFFED BY APPROXIMATELY 400 VOLUNTEERS WHO DISTRIBUTED MORE THAN 1.5 MILLION POUNDS OF FOOD AND CLOTHING ANNUALLY TO 1,342 HOUSEHOLDS WHICH INCLUDE 1,512 CHILDREN. THE AMOUNT OF FOOD THEY RECEIVE IS BASED ON FAMILY SIZE WITH NO LIMITATIONS ON NUMBER OF VISITS OR INCOME LEVELS. 85% OF OUR FOOD IS DONATED BY SECOND HARVEST, LOCAL GROCERS AND WHOLESALERS, COMMUNITY MEMBERS, SCHOOLS, AND BUSINESSES.
