THE PROGRAM OFFERS FINANCIAL SUPPORT IN THE FORM OF STEM GRANTS, PRODUCT DONATIONS FROM CORPORATE PARTNERS AND SUBSIDIES FOR ACCESS TO COMMUNITY-BASED STEM PROGRAMS AND RESOURCES.
