IN THE LONG TERM, YOUNG PEOPLE NEED TO FEEL A PART OF NATURE, AND UNDERSTAND THEIR ROLE AS CARETAKERS OF THE NATURAL WORLD. THE INDIANA WILDLIFE

INDIANA GETS 95% OF ITS ELECTRICITY FROM COAL CREATING THE NUMBER ONE SOURCE OF CARBON DIOXIDE RELEASED INTO THE AIR.
