THE REMAINING \$10,856 IS NOT REPORTED AS UNRELATED BUSINESS INCOME FOR IWF AS IWF PARTICIPATES AND PARTNERS WITH THE ASIAN CARP TEAM THROUGH ITS WATER RESOURCES PROGRAMS. THIS IS CONSIDERED AN AGENCY RELATIONSHIP BETWEEN THE CENTER OF ENVIRONMENTAL QUALITY/US FISH AND WILDLIFE SERVICE AND IWF DOES NOT HAVE THE ABILITY TO MODIFY THE TERMS OF EMPLOYMENT FOR THE ASIAN CARP TEAM. AS AN AGENCY TRANSACTION, THE RECEIPTS AND DISBURSEMENTS OF \$170,048 ARE NOT REFLECTED ON THE FORM 990 FOR IWF. IN ADDITION, THE W-2 SALARY OF THE FORMER EXECUTIVE DIRECTOR IS NOT DISCLOSED IN SECTION VII OF THE FORM 990 AS A FORMER OFFICER THAT RECEIVED OVER \$100,000, AND SCHEDULE J HAS NOT BEEN COMPLETED.
