The Lift Garage provided low-cost car repairs for people making 30% of the Area Median Income and below. During the current year, The Life Garage repaired 546 cars saving their customers \$262,885 in car repair costs as compared to purchasing those repairs at current market rates. In addition, free inspections were completed on 144 cars with advice not to spend money to repair the vehicle as the repair outweighed the value of the vehicle. Pre-purchase inspections were performed on 50 cars saving \$2,000 in inspection costs per car and much more in future costs. Inspection only appointments were performed for 117 cars saving \$2,000 in inspection costs per car. Car classes were taught with 64 attendees.
