The organization selects eligible families based on their level of need, willingness to become partners in the program and ability to repay the no-interest loan. The organization conducts training for selected families in homeownership matters, including financial literacy and credit. The organization's staff counsels Habitat families on credit and other homeownership issues throughout the term of their loan (typically 20 years).

The organization obtains building sites and designs and builds decent and affordable homes in partnership with selected low-income families and volunteers.

The Habitat ReStore is a retail business that accepts donations of new and gently-used building materials, furniture, appliances, and housewares and resells them to the general public through a retail storefront warehouse. ReStores help to protect the environment by keeping hundreds of tons of materials out of our landfills and in this tight economy they provide a low-cost outlet for home improvements materials making home renovations and improvements more affordable.
