The presentations focused on current treatment options and the future of care. Speakers reported on treatment beyond cancer progression, managing the central nervous system, and the need for repeat biopsies. Immunotherapy Forum: The forum educated melanoma, kidney and lung cancer patients and their caregivers about the latest advances in immunotherapy treatment. The agenda included cutting-edge scientific presentations from leading clinicians in the immunotherapy field. In addition to general sessions, the forum included melanoma, kidney cancer, and lung cancer breakout groups to focus on cancer-specific issues.
