At the heart of LCF’s efforts is the AZA certified Myakka City (FL) Lemur Reserve (MCLR) The 100-acre campus is comprised of two large forested enclosures, two lemur shelters, a thriving lemur colony, guest houses for scientists and researchers, staff housing, and the Mianatra Center for Lemur Studies including the Bladstrom Library LCF has also partnered with Tampolo Forest Station, a reserve located in Madagascar, to support in situ conservation efforts
