The client-dog teams are Freedom Service Dogs core program and encompasses 3 types of client-dog teams: Professional Service Dog teams, Skilled Companion teams and Professional Therapy Dog teams. A Professional Service Dog team pairs a full public access dog with a person living with disabilities such as a spinal cord injury, Multiple Sclerosis, Cerebral Palsy, Post Traumatic Stress Disorder (PTSD), Traumatic Brain Injury (TBI) or Autism. A Skilled Companion matches a dog that does not have public access with a person with the same disabilities as mentioned above. The Skilled Companion dog can do the same tasks as a Professional Service Dog, but does them at home for the client and does not go out in the public with that person. A Professional Therapy Dog team pairs a licensed therapist with a dog that they will use in their therapy/counseling practice or facility. Client-Dog teams are considered the main metric of our mission, and we successfully paired 31 teams in 2013. FSD provides handler classes for volunteers to learn how to train service dogs and also professional staff visit shelters several times weekly to test potential candidates for service. In 2013, FSD rescued 110 dogs, graduated 31 and placed 79 into loving, forever homes.

Public education and outreach. Annually, FSD provides over 600 hours of educational programs both visiting schools and working with over 180 at-risk youth. Additionally, over 250 kids have been reached by FSD's Professional Therapy Dogs in the Denver metro area alone. In 2013, over 11,000 hours of volunteer service were committed to the many programs of FSD, including events and booth opportunities within the community.
