The Client-Dog Team Program is Freedom Service Dogs core program and encompasses 3 types of client-dog teams Professional Service Teams, Certified Companion Teams and Professional Therapy Teams A Professional Service Team pairs a full public access dog with a person living with disabilities such as multiple sclerosis, cerebral palsy, Post Traumatic Stress Disorder, or Autism A Certified Companion Team matches a dog that does not have public access with a person with the same disabilities as mentioned above The Certified Companion dog can do the same tasks as a Professional Service Dog, but does them at home for the client, and does not go out in public with them A Professional Therapy Team pairs a licensed therapist with a dog that they will use in their therapy/counseling practice or facility Client-Dog Teams are considered the main metric of our mission, and we successfully paired 30 such teams in 2011 FSD provides handler classes for volunteers to learn how to train service dogs and also has professional staff visit shelters several times weekly to test potential service dogs

Public education and outreach - FSD normally annually provides over 80 educational programs and informational booths at schools, service organizations, clubs, churches, fairs, and on television Pawsitive Connection (PC) focuses on character development in troubled and at-risk youth through effective use of the human-animal connection Some children in the program are in foster care, others are challenged with ADHD and other mental health diagnoses Children in the program may have witnessed animal cruelty such as dog fighting, and may be in the juvenile justice system PC utilizes a process which nurtures and enhances each youths positive character traits and is aimed at reducing the risk of engaging in negative coping behaviors Operation Freedom is a partnership developed between Freedom Service Dogs and the United States Veterans Administration This program is designed to help returning war veterans and military personnel through their transition from active duty and combat to civilian life Through Operation Freedom, service members and veterans are placed with highly specialized service dogs that help them find a new level of independence in their post-combat life Many returning military personnel and veterans face a myriad of challenges including PTSD, depression, immobility and inactivity Freedom Service Dogs is proud to rescue, train and provide service dogs to our nations disabled veterans who suffer from these disabilities
