The grants provided by the organization are used to build kitchens, buy ingredients, prepare food, deliver and serve meals, conduct measurement and evaluation, develop technologies to make meal service more effective, as well as to provide general and administrative support. Through the grant assistance provided by the organization, over 34 million meals were prepared and served to children throughout Kenya in the past fiscal year.
