Of those 38 bundles, the Aliver Foundation purchased and donated 17 units and helped provide guidance and support for several municipalities to purchase the additional 17. As part of the placement of the lifesaving equipment bundles, the Foundation hosted over 30 in-person awareness and educational programs in several municipalities in four states: CA, NE, NJ, and PA, with over 2500 people in attendance during these events.
