Make TV our core program provides professional staff to train volunteer producers and facilitate media production and distribution. Annual outcome data filed with the Public Utilities Regulatory Authority PURA includes 168 hours of weekly programming and 456 programs produced in studioW with nearly 4000 media assets managed annually. The facility operates 6 days 55 hours per week. Recognized for Overall Excellence by a New England peer association in 2025 all services are provided entirely free of charge to the public. WPAA does not sell merchandise or charge fees for its services ensuring equitable access to media tools for all residents.

A99 Art and Culture Program Democracy Is A Creative Practice. This initiative hosts storytelling and performance events featuring TV simulcast and onsite attendance. The organization manages an integrated art gallery showcasing photography sculpture upcycled and fine art designed to inspire community engagement and social action. We support festival and competition entries for youth and adult creators and host media making events focused on public interest stories and local history. The program actively engages the community in book publishing and documentary filmmaking. Award winning at the regional and national levels since 2025 all program activities and gallery access are provided free of charge to the public to ensure equitable participation in the creative process.

O99 Youth Training and Empowerment Program TeenTigerTV. This initiative recently honored with the Rika Welsh Award for a decade of community impact provides comprehensive media development for socially and economically disadvantaged youth. The core program consists of an intensive six week summer session 16 hours per week supplemented by extended hours during the school year. In 2025 the program served 12 core summer participants and 35 youth through specialized workshops and a new year round weekly drop in pilot extension. By offering professional grade training and mentorship entirely free of charge TeenTigerTV ensures that financial barriers do not prevent local youth from gaining critical 21st century digital literacy and storytelling skills.

Schedule D, Part III, Line 4 - The Nelson 'Carty' Ford Memorial Gallery, dedicated on April 30, 2024, is an integrated gallery within the gathering spaces and walkways of WPAA-TV and Community Media Center. This permanent collection of 'social action art' is curated primarily from Connecticut artists to engage visitors in a fuller understanding of our collective humanity and the earth we share. In furtherance of our public service mission, all works are held for public exhibition and education; they are not capitalized, not held for financial gain, and are strictly not for sale. The gallery serves as a platform for advocacy through art, highlighting the lived experiences of underserved and socially challenged members of our community.

Schedule D, Part V, Line 4 - The Freeman Purse Fund is an agency endowment established in 2020 with \$80,000 of organization assets to ensure long-term sustainability. Under ASC 958-605, this is reported as an asset of the organization, with the principal restricted to provide a permanent source of income for community media services. A separate Donor Advised Fund (DAF) provided a standard annual grant of \$337 and a significant one-time strategic grant of \$71,800 this year. These endowment funds are intended to provide long-term support for the mission-including media programming, community education, and infrastructure upgrades-as cable franchise fees decline. This filing compiles reporting from the prior five years to correctly represent these funds as an endowment, correcting a prior preparer's classification as a standard investment.

Schedule D, Part VII, Line 3 - Funds represent a quasi-endowment held and managed by Community Foundation For Greater New Haven for the The funds reported represent a quasi-endowment held and managed by the Community Foundation for Greater New Haven for the sole benefit of the association. The Foundation maintains legal ownership while the organization retains a beneficial interest in the funds, which are intended for long-term mission sustainability and community media services. Form 990, Part III, Line 2 - To ensure long term sustainability amid shifting revenue streams the organization expanded its Community Development Strategic Plan. Key milestones included securing Program Related Investments known as PRIs. These are comprised of low interest operational loans and a long term no interest mortgage loan following a successful mortgage payoff. A significant one time Donor Advised Fund award was secured to bolster this strategy providing the required baseline for a matching Arts award in 2026. Furthermore this filing includes a restatement of a quasi endowment known as the Freeman Purse Fund which was previously misclassified as a standard investment. These combined fiscal strategies allow the organization to maintain its core mission and outreach in support of unhoused and socially challenged individuals as reflected in our permanent art collection and advocacy initiatives.

Form 990, Part VI, Section A, Line 4 - The revised purpose states that the corporation is organized for the purpose of empowering the people of Wallingford and beyond to uplift the community through story conversation and content creation by operating a community centric digital media center and public art gallery.

Form 990, Part VI, Section B, Line 11b - The governing body received a full copy of Form 990 and is given the opportunity to provide feedback before the return was submitted. The final version was thoroughly reviewed by the designated officers and the preparer.

All board members are required to disclose potential conflicts and sign updated disclosure statements at the annual meeting. These policies are reviewed by the Board and filed annually with the state regulator to ensure continued transparency and compliance

As part of this process, the board determines the estimated value of these services to be recorded as inkind contributions in the organization financial statements

Form 990, Part IX, Line 12 - The expenses reported on Line 12 represent professional service fees and project specific costs for our core programs. This includes 3803 dollars for the A99 Art and Culture program covering gallery management festival submission fees and specialized content creation including production props and costumes. The remaining balance is allocated to the production of Make TV bilingual content and costs associated with Mission Continues a series of free to attend public open house events designed to engage the community in media literacy and local advocacy.

Form 990, Part X, Line 33 - Per the strategic plan this return aligns property and endowments and mission investments. The facility is the primary space for Make TV. To offset lower cable revenue the Board created an endowment in 2020 held by the Community Foundation. This growth fund with current balance of 88493. And PRI investments of 65000 dollars Capital for Change and 200000 dollars in support for Ray Rays Place. A 2025 funding amount of 71800 dollars and a one time gift of 121556 dollars were received for a 2026 matching program. This filing recognized a prior period adjustment clarifying that a 15000 dollar fund at the Community Foundation is not an asset of this group.

Form 990, Part XI, Line 9 - Line 9 reflects a net reconciliation of asset balances totaling negative 10704 dollars. This amount is comprised of two specific adjustments. First a prior period adjustment of 15000 dollars for Donor Advised Fund which is not an asset of the WPAA. This adjustment aligns the beginning net assets with the our actual cash position. Second a positive adjustment of 25704 dollars was recorded to align the book value of program related investment assets and building depreciation with year end cash and investment statements. These adjustments ensure the final net assets reported are consistent with current verified financial holdings.
