Enrichment includes English, Technology, eLearning, Events, Libraries, Sports, Music and Arts. A total of 524 students were enrolled in English courses at 5 PLF locations. A total of 336 students took technology courses at 5 PLF locations and 87 students took eLearning courses at 3 PLF locations. A total of 113 students participated in Chess clubs at 4 locations. 41 grade 4 students took Arts and Crafts classes and 65 students took Science Lab. A total of 1,386 students had access to lending libraries at 8 locations with 51,101 books borrowed for the year. The organization supports the education of 3,000 students who live in rural poverty in Cambodia.

142 High School Scholarships were awarded for National Exam Prep. 6 Full scholarships were awarded for Vocational Training. 43 full University Degrees were awarded for Bachelors Degree. 70% of the University scholarships were for STEM subjects and 54% were awarded to girls.

The Food & Wellness Program provides either breakfast or lunch to students at 4 locations and provides hygiene supplies and training at 3 locations (primary school) During the year 478 students were provided breakfast 6 days per week and 229 students were provided lunch 6 days per week. Food Banks at three locations served 245 students and their families. Clean water systems, hand-washing and tooth-brushing stations and latrines are provided at 6 rural locations. Hygiene is taught at 3 remote locations and all materials are provided. First aid supplies are provided to trained school nurses at every rural location. Transport to hospital is provided to any critically ill students.
