ANY EMPLOYEE WHO BELIEVES THEY HAVE BEEN RETALIATED AGAINST FOR WHISTLE BLOWING MAY FILE A COMPLAINT WITH EITHER THE EXECUTIVE DIRECTOR OR THE CHAIR OF THE BOARD OF DIRECTORS.
