We manage a 219-acre natural area, which includes an African American historic farm and a modern Education Building. The management of the site includes the maintenance of 7 miles of trails, making the historic elements available to the public by opening the barn and offering tours, and coordinating the use of the Education Building by area groups, many of whom in turn offer educational programming. We offer an array of educational programming ourselves, including environmental, historical, cultural, and hybrid (for example, a tour showing how the history of the farm affects the forest seen today). Education is offered through physical exhibits, tours, in-person programs, Zoom lectures, our website, and social media, and is offered to ages ranging from preschool-age Little Naturalists to adults.
