We work within the community with the Division of Family and Children Services, the juvenile judicial system, educational professionals, and service providers to ensure healthy outcomes for children experiencing foster care. CASA volunteers are specially trained adults appointed by the court to improve a child's foster care experience. These trained volunteers work to promote safe and stable homes for children in times of family crisis while also providing individualized support to children in foster care. These volunteers get to know each child on a one-on-one basis by monthly visitation, school advocacy, extracurricular involvement, and by building relationships with the important people in each child's life.
