1 Briefly describe the organization's mission: Girls on the Run Georgia empowers girls with vital social-emotional skills to help them succeed in school, at home, and within friendships. Our programs, Girls on the Run (3rd-5th grade) and Heart & Sole (6th-8th grade) are taught by trained coaches and are intentionally designed for the critical adolescent years when girls experience decreases in confidence and challenges with their mental, social and emotional health. Every girl can participate, no matter her physical ability or her family's financial means. Since 2000, we've helped more than 45,000 girls learn to "let her star shine." Our research-based, positive youth development program utilizes proven curriculum based in social-emotional learning (SEL) to deliver skills in building self-confidence, positive self-talk, managing emotions, navigating difficult conversations, standing up to bullying, and more.

Since 2000, Girls on the Run Georgia has served more than 45,000 girls and expanded to more than 150 schools and community sites across Greater Atlanta, North Georgia, Athens and Golden Isles. It has been our long-standing priority to mirror our participants with the demographics of the communities we serve and we are proud that we are succeeding. This year, 2,132 participants participated in our life-changing programs. 73% of our participants were BIPOC, 60% reside in low-income, under resourced communities with limited access to youth development programs. 98% of girls reported they were more confident due to their participation in our programs. Service to our amazing girls is enabled by a dedicated team of eight staff members, with the generous support of more than 1,000 volunteers serving as coaches and event volunteers, as well as those in leadership positions on our Governing Board and Young Professionals Board. Looking to the future, Girls on the Run Georgia hopes to bring our programs to any girl within our region!
