1 Briefly describe the organization's mission: Our mission is to strengthen the communities of James Is. & Folly Beach by providing a range of services to our clients, uniting the community in service to those in need, and by improving the quality of life for all.

4a (Code: ) (Expenses \$ 735,821. including grants of \$ 525,934. ) (Revenue \$ ) Food assistance is provided through a client-choice pantry to promote client empowerment and health. Clients are able to choose from fresh produce and meats, bakery items and non-perishables based on household nutrition needs and preferences. Serving an average of 245 households per month, 260,332 pounds of food, valued at \$450,374, was distributed to neighbors in need. An additional 56,445 pounds of food, valued at \$97,650, was distributed to other non-profit organizations fighting hunger in the Charleston community.

4b (Code: ) (Expenses \$ 82,075. including grants of \$ 35,877. ) (Revenue \$ ) Financial assistance and referrals are provided to help neighbors experiencing financial hardship, housing insecurity and other economic challenges. Emergency assistance with utility and rent bills totaling \$36,893 was provided to 199 households. Through partnership with the Trident United Way AmeriCorps Program, a family navigator provides 1:1 consultations to assist with public and private benefits applications, eligibility screening and snap and Medicare application assistance.

4c (Code: ) (Expenses \$ 156,451. including grants of \$ 120,485. ) (Revenue \$ ) The Hart Critical Home Repairs Program helps clients with critical repairs such as leaking roofs, damaged floors, plumbing leaks and window replacements. Home repairs totaling \$122,743 were accomplished in 2024 covering 23 separate projects.
