During the year ended September 30, 2024, unpaid volunteers contributed more than 240 hours of their time in direct support of the organization. Volunteers assisted in various program areas. Based upon the hourly volunteer rate of approximately \$33.49/hr. In 2024 for the state of Florida per the Bureau of Labor Statistics, the dollar value of those volunteer hours was approximately \$8,100. A total of 21,130 hours of volunteer services valued at \$707,600 were provided in total to the agency and its related parties. No amounts have been reflected in this return for those donated services.
