THE AVERAGE UNEMPLOYMENT RATE ACROSS THE NEIGHBORHOODS ADJACENT TO OUR MINISTRY IS MORE THAN THREE TIMES THE RATE IN THE CITY AND THE COUNTY. UNEMPLOYMENT AND POVERTY ARE TWO OF THE GREATEST CONTRIBUTING FACTORS TO CRIME AND BEHAVIORS THAT LEAD TO ARRESTS. 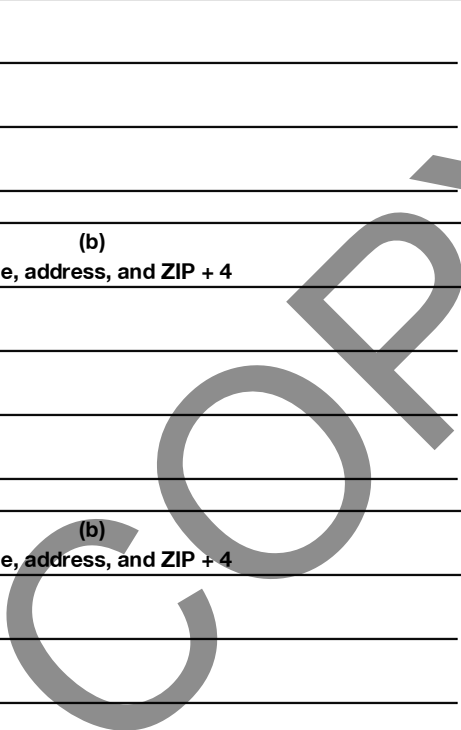

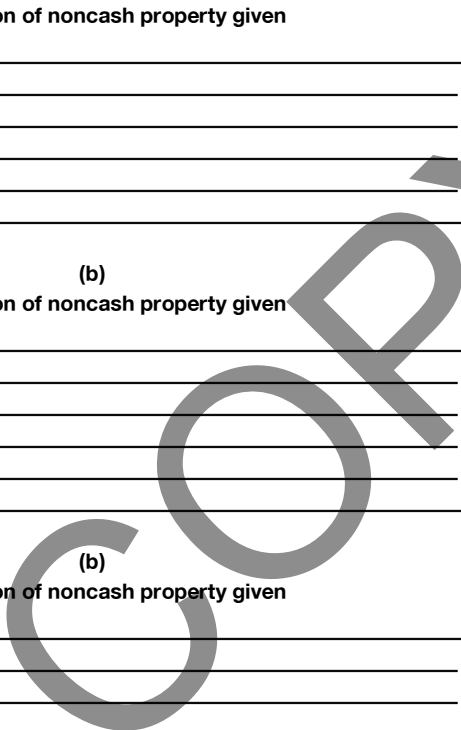

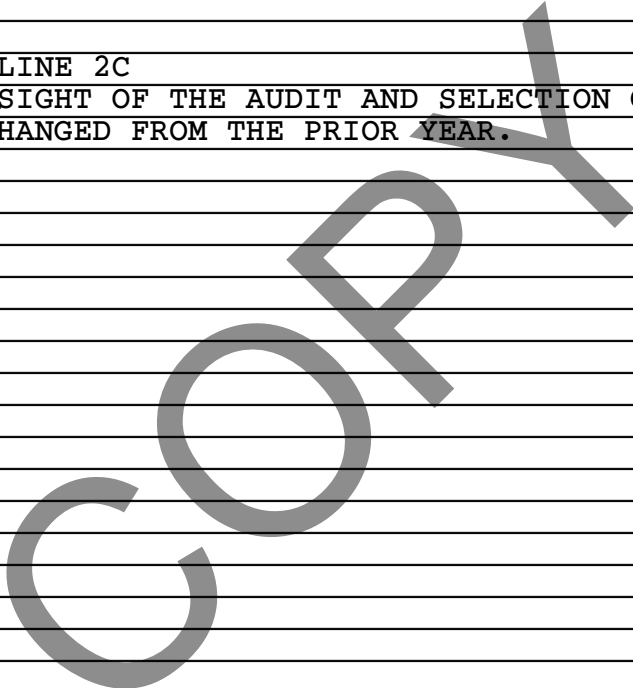
