THE ORGANIZATION ALSO LEASED TWO HOMES DURING THE FISCAL YEAR TO PARTNER FAMILIES IN THE HABITAT SWEAT EQUITY PROCESS, OR TO FAMILIES OBTAINING HOUSING USING OTHER AFFORDABLE MORTGAGE PRODUCTS.

THE HOMEOWNERSHIP CENTER HELPS PEOPLE EXPLORE, PREPARE FOR, AND SUSTAIN SUCCESSFUL HOMEOWNERSHIP. THIS INCLUDES PRE-PURCHASE COUNSELING, HOMEBUYER TRAINING, AND POST-PURCHASE COUNSELING. IN ADDITION TO THE PARTNER FAMILIES THAT PURCHASED HABITAT HOMES THIS FISCAL YEAR, THE HOMEOWNERSHIP CENTER ALSO HELPED FIFTEEN FAMILIES ACHIEVE HOMEOWNERSHIP USING OTHER AFFORDABLE MORTGAGE PRODUCTS. IN JUNE 2020, THE ST. TAMMANY HOMEOWNERSHIP CENTER WAS APPROVED AS A HUD LOCAL HOUSING COUNSELING AGENCY, CURRENTLY THE ONLY SUCH APPROVED AGENCY IN ST. TAMMANY PARISH.
