A "NO KILL CITY" IS DEFINED AS A COMMUNITY THAT SAVES OVER 90% OF THE ANIMALS THAT ENTER ALL THE SHELTERS IN THAT COMMUNITY. THE ORGANIZATION RESCUES DOGS AND CATS WHO ARE AT RISK OF EUTHANASIA OR DEATH DUE TO MEDICAL OR BEHAVIORAL REASONS.
