SOLI's mission is to cultivate and promote the awareness and appreciation of contemporary classical music through commissioning projects, high-caliber performances, cross-genre collaborations, and engaging educational and outreach programs. Through these initiatives, SOLI stretches the boundaries of classical chamber music into a new model of musical expression relevant to the 21st-century experience.

SOLI produced three live outdoor concerts at the San Antonio Botanical Garden, four salon-style events throughout San Antonio, and one community engagement evening at Texas Public Radio, for ca. 575 attendees. SOLI commissioned two new chamber works, presented two world premieres during 2024-2025, and recorded one event for radio re-broadcast.

4b (Code:) (Expenses \$ 35,292 including grants of \$ 0) (Revenue \$ 25,571)

SOLI traveled to the University of Georgia and the University of Central Missouri in Fall 2023 to present public concerts, facilitate reading sessions of student composer works, and to engage with students - both majors and non-majors - at each institution.

4c (Code:) (Expenses \$ 61,581 including grants of \$ 30,000) (Revenue \$ 30,000)

In honor of its 30th anniversary, SOLI initiated the 30x30x30 Project in March 2024, soliciting 293 submissions from a national public call for recently-composed works by early-career composers. A national panel of experts selected 30 works; each will be performed and recorded during the 2024-2025 season by SOLI and partnering organizations around the country. The ultimate goal of the 30x30x30 Project is to give voice to different cultures, heritages, and affinities. Increasing knowledge and understanding of contemporary classical music dissolves barriers, invites connection, and strengthens cultural sensitivity and community across demographics.

Schedule I, Part I, Line 2 - The organization held a competitive selection process to identify 30 composers to receive cash awards for their compositions. The process was designed to ensure fairness and transparency in selecting the most deserving candidates based on merit and artistic quality. First, a public call for submissions was issued, inviting composers from across the country to submit their original works. The organization received a total of 293 submissions by the published deadline. Each submission was evaluated by a panel of five expert judges, including accomplished composers, music professors, and industry professionals. The panel used a scoring system to assess each composition based on specific criteria, such as originality, compositional skill, and instrumentation suitability, and evaluative scores designed to ensure underserved voices were prioritized. After individual scoring, the judges convened to review and discuss the top-ranked submissions. The 30 highest-scoring composers were selected as the final award recipients. Each of the selected composers received a \$1,000 cash award to support their ongoing work in music composition. The selection process ensured that all candidates were evaluated fairly and without bias, with emphasis on the artistic merit of their submissions. No other factors, such as personal connections or geographic location, were considered in the selection process.

The process ensures ongoing monitoring and adherence to conflict of interest requirements throughout the year.
