Through these initiatives, SOLI stretches the boundaries of classical chamber music into a new model of musical expression relevant to the 21st-century experience.

In addition to the accomplishments below, the ensemble co-commissioned two new chamber compositions, conducted a multi-day residency at the University of Houston, and recorded two works for a future commercial release.

SOLI Chamber Ensemble presented the world premiere of Cancionero de luto by composer Armando Bayolo at St. Mark's Episcopal Church in San Antonio, Texas, for an audience of over 200. Co-commissioned by SOLI Chamber Ensemble and Yale University, this poignant new work reflects on the 2022 Robb Elementary School tragedy and other acts of violence. Scored for small ensemble and chorus, the performance marked SOLI's second collaboration with the San Antonio Chamber Choir.

During the 2024-2025 season, SOLI's 30x30x30 30th Anniversary Project continued to flourish. SOLI performed and recorded 22 of 30 works selected for the project in partnership with national collaborators. The Ensemble also hosted eleven of the project composers in San Antonio for two public Showcase weekends that included workshops, Q&A sessions, recording sessions, and live performances, providing audiences direct access to the composers and the creative process behind new chamber music.

These items are initially recorded in inventory at their Fair Market Value (FMV) upon receipt, as determined by the organization's gift acceptance policy. In accordance with the organization's policy (which aligns with relevant financial reporting standards for certain donated goods), contribution revenue is deferred and recognized only when the donated item is sold at auction. Of the total \$23,303 FMV of goods received: \$1,650 represents the FMV of auction items (goods) that were sold during the current tax year. This amount is included in the organization's Part VIII, Line 1g (Noncash contributions) and the corresponding special events revenue line. \$21,653 represents the FMV of auction items (goods) that remain unsold at the end of the tax year. This value is reported as noncash contributions received on Schedule M (and included in the total on Part VIII, Line 1g), but the contribution revenue recognition is deferred. This value is carried on the organization's Balance Sheet (Part X) as inventory and a corresponding deferred revenue or net asset adjustment. The revenue associated with the deferred amount of \$21,653 will be recognized as a contribution in the subsequent tax year when these items are sold at a future event. Donated Services Disclosure The organization also received \$200 in donated noncash services during the tax year that were related to the auction. In accordance with Form 990 instructions, the Fair Market Value of these donated services is explicitly excluded and is NOT reported as revenue in Part VIII or included in the noncash contributions total on Schedule M.
